### The opening ceremony of “Capacity Building Workshop for Lancang-Mekong Industrial Gas Emission Standards and Management” was held in 27<sup>th</sup> February, 2017

As an activity of the Lancang-Mekong Environmental Cooperation Mechanism, supported by Asia Regional Cooperation Special Fund of Ministry of Foreign Affairs, and guided by the department of international cooperation of Ministry of Environmental Protection, Capacity Building Workshop for Lancang-Mekong Industrial Gas Emission Standards and Management was held in Beijing, China during 26th February to 15th March, 2017.

Officials from Cambodia, Laos and Myanmar were invited to attend this workshop and discussed industrial gas emission standards and governance. Experts from related institutions like Chinese Research Academy of Environmental Sciences, China National Environmental Monitoring Center were invited to give lectures about air pollution governance policies and standards system of China. The delegates were organized to visit some demonstration places to carry out research and discussion.

Participants were invited to visit CRAES, knowing about emission standards of waste gas of thermal power plant in China. They also visited the atmospheric laboratory of CRAES.

During the workshop, participants from Mekong countries were organized to visit Yixing and Suzhou of Jiangsu province, Huzhou of Zhejiang province, and Changsha of Hunan province, where they had symposiums with local environmental departments, environmental protection industry parks, environmental protection enterprises, and textile enterprises, comprehensively understanding China's experience and lessons on industrial waste gas management.

- Participants visited textile companies and waste water treatment plant in Huzhou of Zhejiang Province and Suzhou of Jiangsu Province, understanding more about local experiences and lessons on waste water and waste gas emission management of textile industry in China;
- Participants visited Changsha of Hunan Province, having seminars with local environmental department and environmental protection enterprises.
