

Green Lancang-Mekong Initiative: China-Cambodia Cooperation Workshop on Water Pollution Control Demand Wraps Up Successfully



On November 17, 2020, the Green Lancang-Mekong Initiative: China-Cambodia Cooperation Workshop on Water Pollution Control Demand was successfully held both "online and offline". The workshop was organized by the Foreign Environmental Economic Center (FECO), Ministry of Ecology and Environment/Lancang-Mekong Environmental Cooperation Center (LMEC) and Belt and Road Environmental Technology Exchange and Transfer Center (Shenzhen). Present were representatives from the Department of Water Quality Management, Ministry of Environment, Cambodia, and experts from research institutions in China.

At the workshop, LMEC representatives focused on the achievements in the research of water pollution control demand in Cambodia as well as industrial cooperation between China and Cambodia, and analyzed the current wastewater treatment situation and challenges in this regard in Cambodia and discussed the cooperation potential for China and Cambodia in water pollution control.
